The Building Safety Act 2022

The Building Safety Act 2022, Section 11, states that there is a new liability applying to manufacturers and distributors of construction products to be held accountable where the product used in works causes or contributes to a dwelling being unfit for habitation. It contains provisions intended to secure

the safety of people in or about all buildings and to improve the standard of buildings. This is currently only relevant where products are in breach of regulations, are inherently defective or mis sold, however there is the prospect that this could apply to all construction products in the future.

The Code for Construction Product Information (CCPI) is there to ensure information on construction products fulfils the obligation of this section of the Building Safety Act, by making sure information is communicated in a clear and accurate way.

The Code for Construction Product Information (CCPI)

What is the CCPI?

The Code for Construction Product Information (CCPI) was created to promote an urgent and positive culture and behavioural change in the way the construction product manufacturing industry manages and provides information on their products.

The CCPI was initiated by the Construction Product Association as a direct response to Dame Judith Hackitt's review of Building Regulations and Fire Safety set up following the Grenfell Tower tragedy. Her review highlighted the need for construction product information to be communicated in a clear and accurate way.

As the Building Safety Regulator and National Regulator for Construction Products (NRCP) become established, CCPI is an effective way to help the industry demonstrate it is up to the challenge and responding to the issues being raised.

What are the benefits of the CCPI?

The CCPI helps organisations to drive higher standards in the presentation of construction product information, prioritising building safety.

The CCPI is built around five 'acid tests'. It helps to provide assurance that any product information, whether written in a brochure, a presentation, on a website or social media must be proven with appropriate evidence that is:

- ✓ Clear
- ✓ Accurate
- ✓ Up-to-date
- ✓ Accessible
- ✓ Unambiguous

CCPI will seek to provide assurance that users of product information have the necessary facts when making decisions about specifying or installing their verified products.

The aim is that clients, specifiers and users will insist on only working with CCPI compliant products.

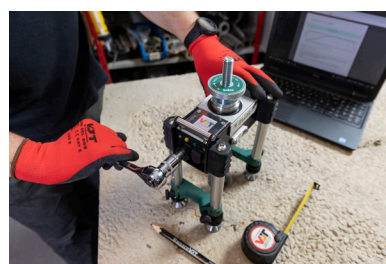
